- 1. How many external international hires has Aneurin Bevan Health Board made over this period? 374

3. What is Aneurin Bevan Health Board total international recruitment spend for this period?

The Health Board's spend for the period January 2021 to present is broken down as follows:

April 2020-March 2021 = £784,283 April 2021-March 2022 = £551,417 April 2022-January 2023 = £537,810

Please note the financial spend relates to the financial years April 2020 – January 2023 as this is how the Health Board accounts for its spend.

4. What percentage of international recruitment is done directly (if any)?

50.80% of the international recruitment during the period stated was undertaken through a centrally coordinated recruitment campaign.

50.20% was undertaken through ad hoc international applications from vacancies advertised on Trac.jobs and NHS Jobs.

5. How much of this budget was spent on external agencies? Who are the agencies and what is their cost per agency?

The agency fee expenditure for the requested period was £400,000.

The Health Board engaged with the following agencies during the period specified:

The Health Board is not able to provide a cost per agency as it is a commercially sensitive contract between two parties and exempt from disclosure under the Freedom of Information Act 2000 (Section 43) Commercial Interests.
