Dyslexia

The Health Board does not hold this information. You may wish to contact Local Education Authorities as they will hold this information.

Please note where less than five (5) patients have been identified, Section 40 of the Freedom of Information Act 2000 has been applied as the Health Board cannot provide the exact numbers due to the low numbers of individuals involved (5 or less). The Health Board believes there is a potential risk of individuals being able to be identified, when considered with other information already available within the public domain, if this was disclosed. Therefore, the data is classed as personal data as defined under the General Data Protection Regulation (GDPR) and Data Protection Act 2018 and its disclosure would be contrary to the data protection principles and constitute unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This exemption is absolute and therefore there is no requirement to apply the public interest test.

Adult Services ADHD

The ADHD diagnostic and assessment service for adults within the Health Board commenced on 30th June 2022. As this is a new service there is currently no waiting list. However, it is anticipated that a waiting list will be required to manage the demand once referrals are received.

Autism

The Health Board only provide an assessment and diagnostic service for individuals who are already under secondary Mental Health Services. The Integrated Autism service provide this service for all other individuals under the Health Board catchment area.

There are currently 22 people waiting for an assessment with the Health Board. However, before an assessment can be offered a questionnaire is sent out for completion. The Health Board are currently waiting for these to be returned.

Dyspraxia, Dyslexia and Tourette's Syndrome

Adult Services within the Health Board do not currently provide an assessment and diagnostic service for these.
