2) The number of nurses or support workers who support patients regarding their housing while they are inpatient in a mental health unit. These could be housing officers, housing support workers, special housing nurses, or similar professions that are specialised in housing support.

- The Health Board has one (1) WTE Housing Manager. The post commenced internally in January 2020.
- There is currently a vacancy for one (1) WTE Patient Flow Co-ordinator. The original post started in February 2020 and had been filled until May 2021. This is a permanent post and the individual will be working across all wards when there is a housing need/benefit need, or delay discharged need.
- There is a third sector provider that support inpatients on our Ty Cyfannol ward (1 WTE). There is a third sector provider that support inpatients on our Carn-Y-Cefn ward (1 WTE).
- There is a third sector provider that support inpatients on our Talygarn ward (1WTE).

3) The number of nurses or support workers who support mental health patients regarding their housing while they are in the community. These could be housing officers, housing support workers, special housing nurses, or similar professions that are specialised in housing support.

There is an additional patient flow co-ordinator one (1) WTE who supports patients with housing/additional needs in our Newport CRHTT service, this role started in January 2021 (ABUHB internal post).

A third sector provider also has a drug and alcohol case worker one (1) WTE who works alongside the Caerphilly Drug & Alcohol team with inpatients or patients accessing CRHTT/CMHT services.

Any additional services provided by the Local Authority or Third Sector provision not based within our services cannot be provided. This information would need to be requested from the Local Authority or directly from service providers.
