Request 1: Please confirm how many whole time equivalent (WTE) physiotherapists, technicians and assistants, by Agenda for Change (AfC) band, were employed by Aneurin Bevan University Health Board (children & young people's services and adult services) on the 31st of March 2021.

This should include any generic assistant or technical instructor posts that support physiotherapy service provision. Also, please note that physiotherapy staff work in a range of clinical settings. The answer to this request must also capture physiotherapy staff not directly linemanaged by the head of physiotherapy services eg occupational health, community resource teams (CRTs).

Request 5: Please confirm or deny if there have been any discontinued posts and/or services in the last year (April 2020 to end of March 2021). If confirmed, please provide details.

No discontinued services or posts.

Routine face to face outpatients were paused during both the first and second wave of the COVID-19 pandemic and were replaced with telephone and video appointments. These have now been reinstated but capacity is limited due to social distancing restrictions and available treatment space.

Request 6: Please confirm or deny if there has been any increase or decrease in demand for physiotherapy services in the last year (April 2020 to end if March 2021). If confirmed, please provide details.

Mainstream Physiotherapy inpatients: there has been an increase in the demand for inpatient physiotherapy following the opening of the Grange University Hospital in November 2020.

Mainstream physiotherapy outpatients: there has been a decrease in outpatient referrals received from 51,086 in 2019 – 2020 to 19,590 in 2020 – 2021. This represents a decrease of 62% which is due to the COVID-19 pandemic. Also the service introduced a direct access service (Primary Care Calls (PCC)) which received 9341 referrals. Therefore the actual reduction of referrals is 57%.

We are currently unable to provide any inpatient data.

Newport CRT: There has been a gradual increase in demand for Newport CRT physiotherapy over the past year which appears to be linked with the lifting of each lockdown. This increase in demand over the year has resulted in longer waiting lists than usual.

The demand has increased from GPs and other physiotherapy services who were not undertaking the pre-COVID volume face to face clinics and requesting the CRT Physiotherapy service to visit people at home instead of them attending clinic appointments.

CNRS (Community Neuro Rehabilitation Service): There was an increase in demand during the first wave of COVID-19, this was supported by the temporary engagement of an agency physio and redeployment of three physiotherapists and a physiotherapy technician from suspended outpatient services.

Torfaen CRT: Unfortunately there is no data captured specifically for Physio demand.

Frailty portal referrals for Reablement (Physio, OT, Reablement therapist are combined) are as follows:

April 2019 – March 2020 = Total referrals 1,871 April 2020 – March 2021 = Total referrals 1,566

Caerphilly CRT: Increase in referrals due to COVID-19

Request 7: Please provide details of the level of budget increase or reduction made by the physiotherapy service in Aneurin Bevan University Health Board in the last financial year (April 2020 to end of March 2021) and what this is as a percentage of the physiotherapy budget.

There was an increase of 0.61% in the core physiotherapy budget.

Torfaen CRT: The physiotherapy budget was increased by £22,208 (15.66%).

Request 8: Please provide details of projected % budgetary savings to be made for this financial year (April 2021 to end of March 2022).

Core physiotherapy service: 1.58% CRTs: All CRTs are required to achieve a 10% budget saving.

CNRS (Community Neuro Rehabilitation Service): 1.58% Torfaen CRT 3%
